

## **2018 RELEASE AND AGREEMENT NOT TO SUE**

**To be signed by all attendees/participants/instructors/spectators/committee members**

By attending Alpine 4-H Horse Camp and all related activities, I hereby accept and agree to the following;

In consideration of being allowed at Alpine Wyoming. 4-H Horse Camp, to be held at Alpine, Wyoming, I and my heirs, successors, personal representatives and next of kin, hereby RELEASE, WAIVE, DISCHARGE and agree to HOLD HARMLESS any and all volunteer, Alpine 4-H Horse Camp committee members, University of Idaho employees, Camp Association or any officers or agents, all instructors, and/or representatives from all claims and liability for all loss of damage, and any claim of damages therefore on account of any injury to my person including death or damage to my property while I am at Alpine 4-H Horse Camp, Alpine Wyoming, their facilities or participating in any and all activities.

I, hereby represent to Alpine 4-H Horse Camp that I understand that THERE ARE CERTAIN RISKS OF SERIOUS INJURY AND DEATH inherent in riding activities and/or around animals and/or participating in equine related activities. I realize conditions of the equine activities or events at Alpine 4-H Horse Camp change from time to time and may become more hazardous when dealing with equine or bovine animals which I voluntarily assume because I choose to participate in these events. I make this choice even though I may or may not have observed or participated in events of this kind, I understand that conditions, facilities, animals and other activities on this property may pose a danger to me and/or my family. I recognize and expressly agree to assume the entire risk of any and all accidents or personal injury including serious paralysis or death, which I and/or a member of my family/guest, might suffer during activities in conjunction with said activities.

I further AGREE NOT TO SUE camp committee, instructors, representatives, as listed above, for any injury, damages or death which occur as a result of my participation in any event which takes place at Alpine 4-H Horse Camp/Alpine, Wyoming property and any claim or damage therefore, I understand that this document may be treated as a complete defense to any legal action I might bring

against any/all Alpine 4-H Horse Camp representatives for any injuries or other damages I might suffer.

**WARNING:** I understand that under Idaho law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Idaho Statutes; **the Equine Activities Immunity Act House Bill No. 526 Chapter 18, Title 6, Idaho Code 6-1801 and 6-1802.**

I understand and agree this RELEASE AND AGREEMENT NOT TO SUE extends to any and all claims I may have, including, but not limited to, claims arising out of participation in events, claims with respect to the design, manufacture, repair, or maintenance of facilities or equipment which I will be using, or with respect to the conditions, qualifications, instructions, rules or procedures under which my use of said facilities or equipment are conducted or from any other cause.

I UNDERSTAND AND AGREE THIS RELEASE AND AGREEMENT NOT TO SUE extend to ACCIDENT, INJURY, and OR DEATH OCCURRING DURING THE TERM of events while at the Alpine 4-H Horse Camp located at Alpine, Wyoming. Any subsequent Releases and agreement I might sign in the future shall amplify, but shall in no way limit, the provisions of this document.

I further state and certify that I have carefully read the foregoing Release, know the contents thereof and sign this release and agreement Not to Sue as a free and voluntary act. I am not relying on any statements of representations of any party released hereby.

Full permission is given to Alpine 4-H Horse camp to use photographs, video's and/or streaming taken during this activity is given without payment reimbursement or fees for use.

By signing the attached form I hereby agree to abide by all the above and realize these apply in all respects and or by attending the Alpine 4-H Horse Camp event.
